Remove promptly all visible waste materials to avoid being trampled and spread about, place in plastic bags or other containers which prevent fibre and/or dust emission, and dispose of in accordance with local waste disposal authority requirements.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.

Care should be taken to minimise dust release when opening boxes or bags. If power tools are used, these should be fitted with exhaust extraction at the point of dust generation, or other effective local extraction.

Materials should be used and handled in a wet, rather than dry form where workable. Work areas should be cleaned regularly to remove any build up of fibres and/or dust.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment regularly, separate from other laundry to avoid cross-contamination and subsequent skin irritation of non-workers.
